Further to the e-mail below, I also thought it useful for me to take the opportunity to follow up on our introductory chat from earlier this month.

First, you made the kind offer for me to visit the Welsh Government offices in Cardiff. I think that would be useful, particularly given that I'm so close by, and the start of September may be a good time for that. Fridays tend to be my quietest day, so if there was a time on a Friday towards the end of August that suited you, that would be great.

Next, you also asked for more details around the level of detail in policy proposals. I've looked into that, but the level of detail can vary depending on the type of case and as I'm new in my role, I haven't been dealing with many policy proposals. As such, I think it's probably best you speak to [Redacted] at the Treasury. [Redacted] prepares the policy proposals for England, so I think it might be more useful for you to ask him to talk you through the process he goes through when preparing a proposal.

Finally, you mentioned that classification of the Circuit of Wales was a priority for the Welsh Government. I'd be happy to engage with you further on this if it would be useful. Please let me know, and I'd be happy to accommodate.

I think that captures the major points from our conversation, but if there's anything I've missed out please just let me know.
