Hi [REDACTED] / Susan,

Our main comment is that we would prefer you to place greater emphasis that you are modelling the likelihood of a home's occupancy and move away from identification of individual households. This will add a level of 'uncertainty' to the work, which is what you refer to later in the text.

I've included some tracked changes in the document (in particular the title, key-words & conclusions), to minimise the risk of drawing attention to an immediate Privacy concern, but where possible, would appreciate greater emphasis on 'modelled likelihoods' as mentioned above.
