SUMMARY

COVID-19

As a result of the ongoing coronavirus (COVID-19) pandemic, we identified 67 items which were unavailable to UK consumers in June, as detailed in table 58 of the <u>Consumer price inflation</u> <u>dataset</u>. This is down from 76 unavailable items in May and 92 in April. Overall, for the June 2020 CPIH index, we have collected a weighted total of 84.0% (excluding unavailable items) of the number of price quotes collected for the February 2020 index, although the coverage varies across the range of items.

Where items are unavailable due to the coronavirus, their movement has been imputed.

CPIH

The Consumer Prices Index including owner occupiers' housing costs (CPIH) is the most comprehensive measure of inflation. It extends the Consumer Prices Index (CPI) to include a measure of the costs associated with owning, maintaining and living in one's own home, known as owner occupiers' housing costs (OOH), along with Council Tax. Both of these are significant expenses for many households and are not included in the CPI.

Aside from including owner occupiers' housing costs (OOH) and Council Tax, CPIH is otherwise identical to CPI. This means that, aside from these two components, the factors contributing to the CPI rate are the same as those contributing to the CPIH. For example, if food is reported as increasing the CPIH rate, it is also acting to increase the CPI rate. The size of the contributions for components other than OOH and Council Tax are exaggerated in the CPI compared with the CPIH because they account for a larger proportion of the overall index.

The <u>National Statistics</u> status of the CPIH was reinstated on 31 July 2017. <u>A letter from the Director General for Regulation to the National Statistician detailed the actions that were taken to meet the requirements as set out in the <u>CPIH assessment report</u>.</u>

The main movements for CPIH in June 2020 are:

- The all items CPIH is 108.8, up from 108.6 in May.
- The all items CPIH annual rate is 0.8%, up from 0.7% in May.
- As a direct result of the challenges that we have encountered due to the coronavirus pandemic, we are postponing the publication of the CPIH excluding indirect taxes supplementary series,
 CPIHY. The series will next be published with the July dataset in August.
- The OOH component of CPIH is 107.9, up from 107.8 in May.
- The OOH component annual rate is 1.2%, up from 1.1% last month.



- The CPIH all goods index is 104.9, up from 104.8 in May.
- The CPIH all goods index annual rate is -0.5%, up from -0.9% last month.
- The CPIH all services index is 111.6, up from 111.5 in May.
- The CPIH all services index annual rate is 1.7%, down from 1.8% last month.

Consumer Prices Index (CPI)

The CPI continues to be a National Statistic and is a measure of consumer price inflation produced to international standards and in line with European regulations. First published in 1997 as the Harmonised Index of Consumer Prices (HICP), the CPI is the inflation measure used in the government's target for inflation.

The CPI is also used for purposes such as uprating pensions, wages and benefits and can aid in the understanding of inflation on family budgets. For more information see <u>Users and uses of consumer price inflation statistics</u>.

The main movements for CPI in June 2020 are:

- The all items CPI is 108.6, up from 108.5 in May.
- The all items CPI annual rate is 0.6%, up from 0.5% in May.
- As a direct result of the challenges that we have encountered due to the coronavirus pandemic, we are postponing the publication of the CPI excluding indirect taxes, CPIY, and the CPI at constant tax rates, CPI-CT, supplementary series. These series will next be published with the July dataset in August.
- The CPI all goods index is 105.0, up from 104.8 in May.
- The CPI all goods index annual rate is -0.5%, up from -0.9% last month.
- The CPI all services index is 112.6, up from 112.5 in May.
- The CPI all services index annual rate is 1.8%, down from 1.9% last month.

Retail Prices Index (RPI)

In accordance with the Statistics and Registration Service Act 2007, the Retail Prices Index and its derivatives have been assessed against the Code of Practice for Official Statistics and found not to meet the required standard for designation as National Statistics. The <u>full</u> <u>assessment report</u> can be found on the UK Statistics Authority website.

The RPI is a legacy measure of UK inflation that continues to be published because of its use in long-term contracts and index-linked gilts. For further information see <u>Users and uses of consumer price inflation statistics</u>.



The UK Statistics Authority recommended in 2019 that the publication of the RPI should be stopped at a point in the future and that in the interim, the shortcomings of the RPI should be addressed by introducing CPIH data sources and methods into its production. The Authority and HM Treasury have launched a consultation on the Authority's proposal to address the shortcomings of the RPI. HM Treasury is consulting on the appropriate timing for the proposed changes to the RPI to take place. The Authority is consulting on how to make its proposed methodological changes to the RPI in a way that follows best statistical practice. The consultation was originally scheduled to run until 22 April 2020 but, because of the coronavirus (COVID-19) pandemic, the period has been extended to 21 August 2020. The UK Statistics Authority and HM Treasury have agreed that they cannot conclude a meaningful consultation with businesses and individuals focused on mitigating the challenges that this public health and economic emergency has created.

The main movements for RPI in June 2020 are:

- The all items RPI is 292.7, up from 292.2 in May.
- The all items RPI annual rate is 1.1%, up from 1.0% last month.
- The annual rate for RPIX, the all items RPI excluding mortgage interest payments (MIPs), is 1.3%, unchanged from last month.
- The all goods RPI is 218.6, up from 218.0 in May.
- The all goods RPI annual rate is 0.1%, up from 0.0% last month.
- The all services RPI is 406.9, up from 406.2 in May.
- The all services RPI annual rate is 2.0%, down from 2.2% last month.

Large upward effects came from:

• Recreation and culture, where prices overall rose by 0.2% between May and June this year, compared with a fall of 0.4% between the same two months a year ago. Within this broad group, the upward contribution came from games, toys and hobbies, particularly computer games and computer games consoles. Prices in this category overall rose by 1.8% this year, compared with a fall of 4.7% a year ago. Over the year-to-date, price movements for games, toys and hobbies have been less volatile than during the same period last year. It is possible that prices have been influenced by the coronavirus (COVID-19) lockdown changing the timing of demand and the availability of some items, particularly consoles. However, it is equally likely to be a result of the computer games in the bestseller



- charts. Price movements for computer games can often be relatively large depending on the composition of these charts; and
- Clothing and footwear, with prices falling very slightly this year, compared with a larger fall between May and June 2019. Price movements this year have not followed the normal seasonal pattern. In recent years, prices have generally risen between January and May before the summer sales season starts in June. During 2020, prices rose as usual between January and February but have since broadly fallen, overall showing a flatter picture than in preceding years, with a greater incidence of sales observed across all months since the beginning of lockdown. That picture has continued into June, with prices relatively stable on the month compared with a 1.0% fall last year, and with the dataset showing that 17.5% of the quotes collected were at sale prices compared with 8.3% last year. The upward contribution to the change in the rate between May and June comes from across almost the full range of men's clothing, while women's clothing shows a more mixed picture across the different products but with the overall effect still upward.

Small upward effects came from:

- Health, where prices overall rose by 1.7% this year, compared with a rise of 0.3% a year
 ago. The effect came from pharmaceutical products, particularly cough liquid, and other
 medical and therapeutic products, particularly daily disposable soft contact lenses. The
 overall upward contribution largely reverses a downward contribution to the change
 between April and May; and
- **Transport**, where prices overall rose by 0.5% between May and June this year, compared with a smaller rise of 0.4% between the same two months a year ago.

A large downward effect came from:

Food and non-alcoholic beverages, with prices falling by 0.6% this year, compared with a
rise of 0.1% a year ago. The effect comprised small movements from a variety of product
groups, with the largest (of 0.03 percentage points) coming from vegetables. The largest
individual downward contribution in this category came from premium potato crisps,
reversing the upward contribution observed between April and May.

Small downward effects came from:

- Restaurants and hotels, where prices overall fell by 0.3% this year, compared with a fall
 of 0.1% a year ago. Part of the contribution came from muffins and individual cakes, but
 part was the effect of imputing for items which could not be priced during June; and
- Alcoholic beverages and tobacco, where prices overall fell by 0.3% between May and June this year, compared with a rise of 0.2% between the same two months a year ago.

Bread and cereals

- Small downward effect.
- Prices overall fell this year by more than a year ago, with the main downward contribution coming from packs of individual cakes.



Milk, cheese and eggs

- Small upward effect.
- Prices overall rose this year but fell a year ago, particularly for yoghurt/fromage frais.

Oils and fats

- Small downward effect.
- Prices overall fell this year but rose a year ago.

Fruit

- Small downward effect.
- Prices overall rose this year by less than a year ago, with the main downward contributions coming from packets of peanuts and blueberries.
- Partially offset by a small upward contribution coming from strawberries, where prices overall
 rose this year but fell a year ago.

Vegetables including potatoes

- Small downward effect.
- Prices overall fell this year but rose a year ago, particularly for premium potato crisps.

Furniture and furnishings

- Small upward effect.
- Prices overall rose this year by more than a year ago, with the main upward contributions coming from items of bedroom furniture. In particular, average prices for single beds rose this year but fell a year ago.





As a result of the <u>error identified in the Retail Prices Index (RPI) in 2019</u> (resulting from an issue with the 2017 and 2018 Living Costs and Food Survey (LCF) dataset, which is used to produce the weights underpinning the RPI), the 2019 RPI was based on two weight structures – prior to July 2019, on the incorrect basis and, from July 2019 onwards, on the corrected basis.

From February 2020, the new 2020 RPI weights structure has been implemented and it should be noted that contributions calculations will be based on the comparison between the latest 2020 weights structure and the structure used at the time of publication. This means that contribution



calculations between now and July 2020 will be based on the uncorrected 2019 weights structure to ensure that no revisions are made to the RPI.

RPI DETAILED BRIEFING

In accordance with the Statistics and Registration Service Act 2007, the Retail Prices Index and its derivatives have been assessed against the Code of Practice for Official Statistics and found not to meet the required standard for designation as National Statistics. A consultation was carried out in March 2013 on whether to maintain this detailed RPI briefing and, based on views received, it was decided to continue with its publication.

Weights are specified as parts per 1000 in the RPI.



RECONCILIATION OF CPIH AND RPI

(Table 5a of the Consumer Price Inflation Dataset)

This table identifies the main factors contributing to the differences between the unrounded inflation rates for the CPIH and the RPI. These differences are broken down into: mortgage interest payments, other housing components excluded from the CPIH, imputed rents (included in CPIH as a measure of owner occupiers' housing costs and excluded from RPI), other differences in the coverage of goods and services, and the formula effect. The final component titled 'other differences including weights' is derived as a residual.

The corresponding figures for the Consumer Prices Index (CPI) can be found in Table 5b of the Consumer price inflation dataset.

The difference between the CPIH and RPI unrounded annual rates in June 2020 was -0.29 percentage points, narrowing from -0.40 percentage points in May 2020.

The main factors contributing to the narrowing were:

- Other differences including weights, which decreased the RPI 12-month rate relative to the CPIH 12-month rate by 0.12 percentage points between May and June 2020. The effect came mainly from games, toys and hobbies and equipment for sport and open air recreation, and to a lesser extent clothing and footwear. This was offset slightly by a widening effect from furniture and furnishings, and liquid fuels. Also, observed effects in this category will encompass differences between imputed price movements, for items that are currently unavailable to consumers to purchase, in the CPIH and the RPI. The coronavirus and the effects on UK prices article describes the approach we have taken.
- Mortgage interest payments, which decreased the RPI 12-month rate by 0.02 percentage points between May and June 2020 but are excluded from the CPIH.

This was partially offset by:

• The formula effect, which increased the RPI 12-month rate relative to the CPIH 12-month rate by 0.02 percentage points between May and June 2020. The effect came mainly from clothing and footwear.

NB: A one percentage point change in the average mortgage interest rate contributes approx. 1.0 percentage points to the 1-month percentage change in the RPI.

Please note that the movements in mortgage interest rates in April and May 2020 are affected by an error in the series for April. In line with the published revisions policy, the series has not been revised. However, the issue has been corrected and does not affect the rate for May or future months.



OUTLOOK

The outlook is a summary of seasonal trends, selected news cuttings and other sources of information. It gives some indication of expected changes to the annual rate of the CPIH and RPI in the next few months.

COVID-19

In preparing to collect the prices for this publication, we identified 67 goods or services across the CPIH/CPI and RPI baskets of goods and services that were unavailable for consumers. These are listed in table 58 of the <u>Consumer price inflation dataset</u>, together with the changes in unavailable items between May and June.

As the collection issues are likely to continue in subsequent months, we are continuing to monitor the resumption of services stopped during the lockdown period, and we will carefully consider how we will reintroduce items in the coming months.

FOOD

Seasonal Food

• Seasonal food prices have shown a mixed pattern of rises and falls in July of recent years, but are typically dependent on weather conditions both in the UK and around the world.

TRANSPORT

Fuels and Lubricants

- Oil prices were little changed recently as the market waits for direction from an OPEC meeting that is expected to recommend an increase in output. That lack of price movement came despite concerns demand could take a hit if some governments reverse lockdowns after global coronavirus cases rose by a record daily amount. Brent LCOc1 futures fell 1 cent to \$43.23 a barrel, while U.S. West Texas Intermediate (WTI) crude CLc1 rose 5 cents, or 0.1%, to \$40.60. (uk.reuters.com 13 July 2020)
- When considering the price of petrol between June and July 2020, it may be useful to note that the average price of petrol fell by 0.9 pence per litre between June and July 2019, to stand at 127.3 pence per litre as measured in the CPIH.
- A 1 pence change on average in the cost of a litre of motor fuel contributes approximately
 0.02 percentage points to the 1-month change in the CPIH.



Passenger Transport by Air

Air fares have tended to rise in July historically.

HOUSING (RPI)

Mortgage Interest Payments (MIPs)

- The Bank of England Bank Rate was unchanged at 0.10% on Thursday 18 June 2020. The
 next announcement and minutes from the Bank of England's Monetary Policy Committee are
 scheduled to be published on 6 August 2020.
- The change in average mortgage interest rates recorded in the RPI was negligible between June and July 2019. The Bank of England Bank Rate remained unchanged at 0.75% in June 2019.
- A one percentage point change in the average mortgage interest rate contributes approximately 1.0 percentage points to the 1-month percentage change in the RPI.
