SUMMARY

CPIH

The Consumer Prices Index including owner occupiers' housing costs (CPIH) is the most comprehensive measure of inflation. It extends the Consumer Prices Index (CPI) to include a measure of the costs associated with owning, maintaining and living in one's own home, known as owner occupiers' housing costs (OOH), along with Council Tax. Both of these are significant expenses for many households and are not included in the CPI.

Aside from including owner occupiers' housing costs (OOH) and Council Tax, CPIH is otherwise identical to CPI. This means that, aside from these two components, the factors contributing to the CPI rate are the same as those contributing to the CPIH. For example, if food is reported as increasing the CPIH rate, it is also acting to increase the CPI rate. The size of the contributions for components other than OOH and Council Tax are exaggerated in the CPI compared with the CPIH because they account for a larger proportion of the overall index.


The <u>National Statistics</u> status of the CPIH was reinstated on 31 July 2017. <u>A letter from the Director General for Regulation to the National Statistician detailed the actions that were taken to meet the requirements as set out in the CPIH assessment report.</u>

The main movements for CPIH in March 2020 are:

- The all items CPIH is 108.6, unchanged from last month.
- The all items CPIH annual rate is 1.5%, down from 1.7% in February.
- The annual rate for CPIH excluding indirect taxes, CPIHY, is 1.5%, down from 1.7% last month.
- The OOH component of CPIH is 107.7, up from 107.6 in February.
- The OOH component annual rate is 1.3%, up from 1.2% last month.
- The CPIH all goods index is 105.7, down from 105.8 in February.
- The CPIH all goods index annual rate is 0.6%, down from 1.0% last month.
- The CPIH all services index is 110.8, up from 110.7 in February.
- The CPIH all services index annual rate is 2.2%, unchanged from last month.

Consumer Prices Index (CPI)

The CPI continues to be a National Statistic and is a measure of consumer price inflation produced to international standards and in line with European regulations. First published in 1997 as the Harmonised Index of Consumer Prices (HICP), the CPI is the inflation measure used in the government's target for inflation.



The CPI is also used for purposes such as uprating pensions, wages and benefits and can aid in the understanding of inflation on family budgets. For more information see <u>Users and uses of consumer price inflation statistics</u>.

The main movements for CPI in March 2020 are:

- The all items CPI is 108.6, unchanged from last month.
- The all items CPI annual rate is 1.5%, down from 1.7% in February.
- The annual rate for CPI excluding indirect taxes, CPIY, is 1.5%, down from 1.8% last month.
- The annual rate for CPI at constant tax rates, CPI-CT, is 1.4%, down from 1.7% last month.
- The CPI all goods index is 105.7, down from 105.8 in February.
- The CPI all goods index annual rate is 0.6%, down from 1.0% last month.
- The CPI all services index is 111.9, up from 111.7 in February.
- The CPI all services index annual rate is 2.5%, unchanged from last month.

Retail Prices Index (RPI)

In accordance with the Statistics and Registration Service Act 2007, the Retail Prices Index and its derivatives have been assessed against the Code of Practice for Official Statistics and found not to meet the required standard for designation as National Statistics. The <u>full</u> <u>assessment report</u> can be found on the UK Statistics Authority website.

The RPI is a legacy measure of UK inflation that continues to be published because of its use in long-term contracts and index-linked gilts. For further information see <u>Users and uses of consumer price inflation statistics</u>.

The UK Statistics Authority recommended in 2019 that the publication of the RPI should be stopped at a point in the future and that in the interim, the shortcomings of the RPI should be addressed by introducing CPIH data sources and methods into its production. The Authority and HM Treasury have launched a consultation on the Authority's proposal to address the shortcomings of the RPI. HM Treasury is consulting on the appropriate timing for the proposed changes to the RPI to take place. The Authority is consulting on how to make its proposed methodological changes to the RPI in a way that follows best statistical practice. The consultation was originally scheduled to run until 22 April 2020 but, because of the coronavirus (COVID-19) pandemic, the period has been extended to 21 August 2020. The UK Statistics Authority and HM Treasury have agreed that they cannot conclude a meaningful consultation with businesses and individuals focused on mitigating the challenges that this public health and economic emergency has created.



The main movements for RPI in March 2020 are:

- The all items RPI is 292.6, up from 292.0 in February.
- The all items RPI annual rate is 2.6%, up from 2.5% last month.
- The annual rate for RPIX, the all items RPI excluding mortgage interest payments (MIPs), is 2.7%, up from 2.5% last month.
- The all goods RPI is 220.2, up from 219.9 in February.
- The all goods RPI annual rate is 1.3%, down from 1.4% last month.
- The all services RPI is 404.2, up from 402.5 in February.
- The all services RPI annual rate is 4.1%, up from 3.7% last month.

Large downward effects came from:

• Clothing and footwear, where prices fell by 0.3% between February and March 2020, compared with a rise of 1.0% between the same two months a year ago. Prices usually rise between February and March, and this year's fall is the first since 2015 and only the second since the start of the constructed CPIH series in 1988. The fall in prices reflects an increase in the proportion of items on sale between February and March 2020, compared with a fall between the same two months a year ago. The effect came from a wide range of women's, men's and children's clothing items. Sales patterns this year are likely to have been influenced by the coronavirus (COVID-19) pandemic. Although prices were collected around 17 March, before the formal government lock-down was introduced on 23 March,



consumer behaviours and retailers' expectations of that behaviour might have changed as a result of social distancing and other precautions. A number of factors might have contributed to the change, including less browsing in physical stores, people spending more time at home where they might have been less interested in clothing and a shift in spending patterns towards other necessities such as food and cleaning products;

- Transport, reflecting a 0.6% fall in prices between February and March 2020, compared with a smaller fall of 0.1% a year ago. The downward effect came almost entirely from motor fuels. Petrol prices fell by 5.1 pence per litre between February and March 2020, compared with a rise of 1.2 pence per litre between the same two months a year ago. This is the largest monthly fall in petrol prices since December 2018. Similarly, diesel prices fell by 5.5 pence per litre between February and March 2020, the largest monthly fall since August 2015. This latest fall compares with a rise of 1.4 pence per litre between February and March 2019. Prices for motor fuels tend to move broadly in line with global prices for crude oil, but the effect is generally muted as consumer prices for motor fuels also include other costs such as transport, duty and retail costs. Global prices for crude oil have fallen sharply in response to reduced global demand during the COVID-19 pandemic and the failure of the Organization of the Petroleum Exporting Countries (OPEC+) to agree to cut supply in early March 2020. Consumer demand for motor fuels has likely also reduced in light of measures taken to curb the spread of COVID-19, including increased working from home and broader travel restrictions. Within transport, the downward effect from motor fuels was partially offset by an upward contribution from air fares, which rose by 5.3% on the month in 2020, compared with a fall of 5.7% a year ago. The fares used in compiling the index reflect departures on 17 March with returns one, two or three weeks later depending on the route. At the point of departure, there were reports of some disruption on European routes, but it was only later in the month when large numbers of flights were suspended. Given that it was not clear that return flights would be cancelled or that travellers would have to make alternative arrangements to travel home, all collected prices have been included in the calculation of the index; and
- Restaurants and hotels, which provided a downward contribution to change of 0.04 percentage points. Overall, accommodation prices fell by 0.3% between February and March 2020, compared with a 1.2% rise between the same two months a year ago. This downward contribution reverses the rise seen between January and February 2020.

A small downward effect came from:

 Recreation and culture, with prices rising by 0.1% between February and March 2020, compared with a rise of 0.2% between the same two months a year ago.



A small upward effect came from:

 Alcohol and tobacco, where the price of tobacco rose by more than a year ago. Duty rates for tobacco products increased from 11 March 2020 as announced in Budget 2020.

Bread and cereals

- Large upward effect.
- Prices overall rose this year by more than a year ago, with the main upward contributions coming from chocolate biscuits, breakfast cereals and packs of individual cakes.

Meat

- Small downward effect.
- Prices overall fell this year by more than a year ago, with the main downward contribution coming from cooked ham.

Milk, cheese and eggs

- Small upward effect.
- Prices overall rose this year but fell a year ago.

Oils and fats

- Small upward effect.
- Prices overall rose this year but fell a year ago, particularly for margarine/low fat spread and spreadable butter.

Fruit

- Small downward effect.
- Prices overall fell this year by more than a year ago, particularly for strawberries.

Vegetables including potatoes

- Small downward effect.
- Prices overall fell this year but rose a year ago, with the main downward contributions coming from premium potato crisps and potatoes.

Sugar, jam, syrups, chocolate and confectionery

- Small upward effect.
- Prices overall rose this year by more than a year ago, with the main upward contribution coming from chocolate covered ice cream bars.
- Partially offset by a small downward contribution coming from cartons/boxes of chocolates, where prices overall fell this year but rose a year ago.

As a result of the <u>error identified in the Retail Prices Index (RPI) in 2019</u> (resulting from an issue with the 2017 and 2018 Living Costs and Food Survey (LCF) dataset, which is used to produce the weights unpinning the RPI), the 2019 RPI was based on two weight structures – prior to July 2019, on the incorrect basis and, from July 2019 onwards, on the corrected basis. From February 2020, the new 2020 RPI weights structure has been implemented and it should be noted that contributions calculations will be based on the comparison between the latest 2020 weights structure and the structure used at the time of publication. This means that contribution



calculations between now and July 2020 will be based on the uncorrected 2019 weights structure to ensure that no revisions are made to the RPI.







RECONCILIATION OF CPIH AND RPI

(Table 5a of the Consumer Price Inflation Dataset)

This table identifies the main factors contributing to the differences between the unrounded inflation rates for the CPIH and the RPI. These differences are broken down into: mortgage interest payments, other housing components excluded from the CPIH, imputed rents (included in CPIH as a measure of owner occupiers' housing costs and excluded from RPI), other differences in the coverage of goods and services, and the formula effect. The final component titled 'other differences including weights' is derived as a residual.

The corresponding figures for the Consumer Prices Index (CPI) can be found in Table 5b of the Consumer price inflation dataset.

The difference between the CPIH and RPI unrounded annual rates in March 2020 was -1.09 percentage points, widening from -0.75 percentage points in February 2020.

The main factors contributing to the widening were:

- Other differences including weights, which increased the RPI 12-month rate relative to
 the CPIH 12-month rate by 0.26 percentage points between February and March 2020. The
 effect came mainly from air fares; insurance; furniture and furnishings; food and nonalcoholic beverages; recording media; clothing and footwear; and overnight hotel
 accommodation. These were partially offset by a narrowing effect from liquid fuels.
- Other housing components, which increased the RPI 12-month rate relative to the CPIH 12-month rate by 0.06 percentage points between February and March 2020. The effect came mainly from house depreciation.
- The formula effect, which increased the RPI 12-month rate relative to the CPIH 12-month rate by 0.02 percentage points between February and March 2020. The effect came mainly from food and non-alcoholic beverages.

There were no significant offsetting factors.

Council Tax

- The Ministry of Housing, Communities and Local Government (MHCLG) announced that the average Band D council tax set by local authorities in England for 2020-21 will be £1,817 a 3.9% increase on last year. (www.gov.uk 25 March 2020)
- Council tax bills had been frozen in Scotland since 2007. From April 2017, the freeze was replaced with discretion for local authorities to increase council tax by a maximum of 3% per



year. For 2020, the Scottish government has signalled that the thirty-two local authorities could raise bills by up to 4.84%. (www.bbc.co.uk 9 March 2020)

- The Welsh Government announced that the average band D council tax for Wales for 2020-21 is £1,667 – a 4.8% increase on last year. (gov.wales 24 March 2020)
- The recorded increase for council tax and rates in the CPIH last April was 4.7%.

TRANSPORT

Fuels and Lubricants

- U.S. crude oil futures turned negative for the first time in history, falling to minus \$37.63 a
 barrel as traders sold heavily because of rapidly filling storage space at a key delivery point.
 Brent crude, the international benchmark, also slumped, but that contract is not as weak
 because more storage is available worldwide. The May U.S. WTI contract fell to settle at a
 discount of \$37.63 a barrel after touching an all-time low of -\$40.32 a barrel. Brent was down
 to \$25.57 a barrel. (uk.reuters.com 19 April 2020)
- When considering the price of petrol between March and April 2020, it may be useful to note that the average price of petrol rose by 3.8 pence per litre between March and April 2019, to stand at 124.1 pence per litre as measured in the CPIH.
- A 1 pence change on average in the cost of a litre of motor fuel contributes approximately
 0.02 percentage points to the 1-month change in the CPIH.

 Air fares have shown variable movements in April which can depend on the position of Easter.

HOUSING (RPI)

Mortgage Interest Payments (MIPs)

- The Bank of England Bank Rate was decreased from 0.75% to 0.25% on Wednesday 11 March 2020, and then to 0.10% on Thursday 19 March 2020. It was not changed further at the subsequent meeting whose minutes were published on Thursday 26 March 2020. The next announcement and minutes from the Bank of England's Monetary Policy Committee are scheduled to be published on 7 May 2020.
- The change in average mortgage interest rates recorded in the RPI was -0.01 percentage points between March and April 2019. The Bank of England Bank Rate remained unchanged at 0.75% in March 2019.
- A one percentage point change in the average mortgage interest rate contributes approximately 1.0 percentage points to the 1-month percentage change in the RPI.
