### **Bank of England's request for pre-release access to ONS statistics in 2022**

Dear Ben,

Thank you for your letter of 2 March 2022 seeking exceptional pre-release for economic statistics to support the work of the Bank of England and the Monetary Policy Committee (MPC).

As outlined in previous letters, when the then National Statistician announced an end to pre-release access to ONS statistics he said that *'Should there be a need for exceptional pre-release access to particular individuals for a specific release this would be fully transparent'*. The overarching principle being that an exceptional circumstance is where the public benefit likely to result from such access significantly outweighs the detriment to public trust in official statistics likely to result from such access.

On that basis, and having discussed this with the National Statistician, the ONS grants you exceptional pre-release access, as requested, for the Monetary Policy Committee (MPC) meetings for the following statistics:

The Consumer Price Index releases that fall on the:

1. 14th September with pre-release access granted such that the data are available for the MPC's meeting at 09:30 on Friday 9th September.
2. 14th December with pre-release access granted such that the data are available for the MPC's meeting at 09:30 on Friday 9th December.

The Labour Market Statistics releases that fall on the:

1. 15th March with pre-release access granted such that the data are available for the MPC's meeting at 14:00 on Friday 11th March.
2. 14th June with pre-release access granted such that the data are available for the MPC's meeting at 14:30 on Friday 10th June.
3. 13th September with pre-release access granted such that the data are available for the MPC's meeting at 09:30 on Friday 9th September.

4. 13th December with pre-release access granted such that the data are available for the MPC's meeting at 09:30 on Friday 9th December.

The Gross Domestic Product releases that fall on the:

1. 13th June with pre-release access granted such that the data are available for the MPC's meeting at 14:30 on Friday 10th June.
2. 12th September with pre-release access granted such that the data are available for the MPC's meeting at 09:30 on Friday 9th September.
3. 12th December with pre-release access grant such that the data are available for the MPC's meeting at 09:30 on Friday 9th December.

We will have further discussions as to exactly what level of detail we provide closer to the time and make the caveat that, although unlikely, figures may change in the final publications.

We will send you the requested statistics 60 minutes prior to the start of the MPC meeting in question.

Ahead of any pre-release access, the ONS will require the names of any and all individuals who will be accessing data ahead of publication.
